**PORTABLE APPLIANCE TESTING GUIDANCE FOR RECIPIENTS**

2. The person ordering the Certificate should have received this Certificate without watermarks and the inspector/company should have retained a duplicate.
3. This Certificate should be retained in a safe place
4. The *AGREED AND OPERATIONAL LIMITATIONS* section should identify fully the extent of appliances or areas covered by this Certificate and any limitations on the testing. The inspector should have agreed these aspects with the person ordering the Certificate and with other interested parties (licensing authority, insurance company, mortgage provider and the like) before the testing was carried out.
5. Some operational limitations such as inability to gain access to appliances or an item of equipment may have been encountered during the inspection. The inspector should have noted these.
6. For safety reasons, the appliances should be re-inspected at appropriate intervals by a skilled person or persons, competent in such work. The recommended date by which the next test is due is stated at the bottom of the first page or on the front cover of the certificate pack.
